# I. INTRODUCTION

From its beginning as a resort community, the City of Dana Point has prided itself on its beach lifestyle, quality neighborhoods, expansive views, and open space. After extensive growth and incorporation, the City now consists of 4,134 acres, 1,993 of which fall in the coastal zone. At build out, nearly 40,000 residents are expected to call Dana Point home, and live in just over 16,000 units. The City is nearly built out, and is expected to add growth through the development of its few remaining vacant lots and reuse of underutilized lands.

To assist Dana Point residents in finding affordable housing and related support, the Economic Development Division of the Community Development Department has developed this Directory. Many of the programs identified within this Directory are offered through agencies or non-profit groups outside of the City; however, it may be possible for assistance to be obtained by residents of Dana Point.

# II. AFFORDABLE RENTAL HOUSING IN DANA POINT

The following apartment complexes have set aside units to low-income families and individuals. Please note that there may be other low income units that are not part of a program and are available throughout the City. Please contact the complex directly for availability.

#### **Orange County Community Housing Corporation**

Orange County Housing and Community Services maintain a listing of apartment communities constructed throughout the County that promote affordable housing. Owners of these properties entered into a commitment to keep rents affordable in a specified number of rental units. Some properties are subsidized and based on tenant income, while others offer rents that are less than the market costs and available to households earning up to 80% of the County median income.

This list is updated on a semi-annual basis by receiving input from all 34 cities in the County. The list may not represent 100% of the deed-restricted units in Orange County due to the limitations of gathering the information. # III. RENTAL ASSISTANCE

#### Section 8 Programs

Section 8 Rental Assistance is a federally funded program that provides rental assistance to very low-income tenants. The Program is available for families, seniors, or disabled persons whose gross family income is less than 50% of the median income for the County.

Currently there are two means of obtaining rental assistance under Section 8. Under the certificate program, the landlord must enter into a contract with the Orange County Housing Authority (OCHA), which limits total rent for the unit involved to federally approved fair market rent level. The tenant would pay 30% of their adjusted gross family income, and the Section 8 program would pay the property owner the difference between what the tenant pays and the federally approved fair market rent.

Under the voucher program, the landlord need not agree to limit the rent level. The Section 8 program would pay the fair market rent, and the tenant would pay the difference between the fair market rent and the actual rent. In both instances, the subsidy is paid directly to the landlord.

#### FAM (Family Assistance Ministries)

Originally known as Family Assistance Ministries, FAM assists those in need with food, shelter, and personalized supportive counsel and aid. FAM also offers rental and utility assistance and provides shelters for families, single women, and mothers with children experiencing homelessness. #### South County Outreach

South County Outreach offers rental and utility assistance to prevent eviction, utility disconnection, and homelessness. ### IV. RENTER'S RIGHTS

The Fair Housing Council of Orange County works to ensure equal access to housing opportunities and eliminate housing discrimination. The FHCOC helps with landlord/tenant problems, such as eviction, discrimination and violation of other laws affecting the renter. They provide fair housing enforcement and education, landlord/tenant counseling, mediation, and homebuyer counseling. For more information on the Fair Housing Council,

# V. ENERGY/UTILITY DISCOUNTS

Southern California Edison offers an Energy Management Assistance (EMA) Program to qualified customers. These customers may receive energy-efficient appliances that help cut costs, while preserving energy. The EMA Program involves three stages, which are carried out by community service agencies and building contractors under SCE's supervision. All customers must provide proof of income; homeowners must provide proof of ownership; and renters must obtain the owner's written permission. The California Department of Community Services and Development administers the federally funded Low-Income Home Energy Assistance Program. The federal Department of Health and Human Services distributes funds to states annually to assist with energy bills and offset heating and cooling costs for eligible low-income households. California's share is approximately \$89 million annually which CSD distributes to contracted community energy service providers.

The U.S. Department of Energy Weatherization Assistance Program (DOE WAP) has long served as the core program for delivering energy conservation services to low-income Californians. The Weatherization Assistance Program reduces the heating and cooling costs for low-income families by improving the energy efficiency of their homes and ensuring their health and safety. Among low-income households, the program focuses on those with elderly residents, individuals with disabilities, and families with children. # VII. OPPORTUNITIES FOR HOMEBUYERS

#### County of Orange Mortgage Assistance Program

The County's Mortgage Assistance Program (MAP) provides silent (deferred payment) downpayment assistance loans to assist low-income first-time homebuyers (FTHB). Eligible FTHB's annual income must not exceed 80% of the Area Median Income (AMI). The loans are designed to help with the down payment to purchase a home. The 3% simple interest, deferred payment loan has a 30 year term and a maximum loan amount of \$80,000. Homebuyers must occupy the property as their primary residence. There is a 1% minimum down payment requirement for this program and the total sales prices shall not exceed 85% of the Orange County median sales price for all homes. All applicants are required to attend a homebuyer education workshop.

#### Federal Housing Administration (FHA) Loans

The Federal Housing Administration has been helping homeowners since 1934. FHA loans can help potential homeowners with low down payments, low closing costs, and easy credit qualifications. #### Home Loan Assistance and Education

The NeighborWorks Orange County provides services and training for clients looking to purchase and maintain their home. Services range from providing comprehensive homeownership education to a wide range of down payment assistance loans and grants. Neighborhood Housing Services partners with lenders and realtors to offer a selection of affordable mortgage products and real estate services that assist homebuyers avoid excessive down payments. #### Workforce Initiative Subsidy for Homeownership (WISH) Program

The Affordable Housing Clearinghouse offers a down payment assistance grant program that provides up to \$22,000 to each household, matching up to \$4 for each \$1 contributed by the first-time homebuyer. Families must not exceed 80% of area median income limits. After 5 years, 100% of grant is forgiven if the buyer remains living in the property. # **VIII. PROGRAMS FOR HOMEOWNERS**

### **Reverse Mortgage**

Retirees with limited income may use the accumulated wealth in their homes to cover basic monthly living expenses and pay for health care through a reverse mortgage. A reverse mortgage is a deferred loan available to homeowners 62 years or older that allows them to convert part of the equity in their homes into cash by pledging their homes as security. Instead of making monthly payments to a lender, as with a traditional mortgage, the lender makes payments to the borrower. The borrower is not required to pay back the loan until the home is sold or otherwise vacated. As long as the borrower lives in the home, they are not required to make any monthly payments towards the loan balance. However, the borrower must remain current on property taxes, homeowners insurance, and homeowners association dues (if applicable). ### Manufactured Housing Educational Trust Program

The Manufactured Housing Educational Trust runs a Rental Assistance Program that provides monthly rent subsidies to qualified mobile home park residents. # IX. CONSTRUCTING AFFORDABLE HOUSING

### Accessory Dwelling Units

In accordance with state requirements, the City of Dana Point allows for the development of accessory dwelling units ("ADU"). According to the Zoning Code, an ADU is an attached or detached residential unit, including complete and independent living facilities for one or two persons, on the same parcel as the primary unit. #### Affordable Housing Fee Waiver Program

The City of Dana Point has established a fee waiver for development permits of qualifying deed-restricted housing units for extremely low income, very low income, and low income households. All City imposed fees related to the processing of development permits and building permits shall be waived for the development of deed-restricted housing units affordable for lower income households. For mixed income developments, the fees for

processing will be discounted proportionally with the amount of deed-restricted affordable dwelling units.

# X. SENIOR CARE GIVING AND ASSISTANCE

### City of Dana Point Senior Center

The Dana Point Senior Center, operated by Age Well Senior Services, offers a wide variety of programs and services designed for any age senior to meet their educational, recreational, social and human service needs. ### **Reasonable Accommodation Ordinance**

The City of Dana Point's Reasonable Accommodation Ordinance provides a process for disabled individuals, or those acting on their behalf, to make requests for reasonable accommodation in regard to relief from the various land use, zoning, or building laws, rules, policies, practices, and/or procedures of the City, and includes a provision of assistance in making the request, as well as for appealing a determination regarding the reasonable accommodation to the Community Development Director.

### Dayle McIntosh Center for the Disabled

The Dayle McIntosh Center provides assistance to people with disabilities that will facilitate both individual and community options for assisted living. The Center disseminates information regarding activities and services for persons with disabilities in both Northern and Southern Orange County sites. An extensive reference system has been compiled that contains information on a wide range of topics such as disability laws, standards for accessibility, and information about recreation, education, and rehabilitation opportunities.
