Paul N Wyatt (Dana Point) stated that his statement was recorded inaccurately in the May 4, 2021 meeting minutes. He provided a history of Short Term Rentals in Dana Point and stated that he is in support of a modified Ordinance with strong leadership and advocacy from the Council.

Steve Didier (Dana Point) suggested modifications to the proposed Ordinance based on his experience working for the City of Carlsbad.

Mark Zanides (Dana Point) endorsed Mr. Wyatt's comments and questioned the legality of the Shor. Term Rental program in the absence of a Zone Text Amendment and Local Coastal Plan Amendment.

Kim Tarantino (Capistrano Beach) addressed the number of Short-Term Rentals listed on the AirDNA website versus the number of permitted Dana Point Short-Term Rentals.

Toni Nelson (Capistrano Beach) listed her concerns regarding the proposed modifications to the Ordinance.

Carol Kelly (Dana Point) read a letter from Denise Iger in opposition of Short-Term Rentals and their effects on neighborhoods.

Barbara Wilson (Dana Point) listed her concerns regarding the proposed modifications to the Ordinance.

City Attorney Patrick Munoz stated that the State of California has taken the position that any city that adopts an Ordinance regulating Sober Living Homes is violating laws applicable to State Housing Element requirements. The State has acknowledged the litigation between the City of Costa Mesa and some Sober Living Home operators in Federal Court, and indicated that even if Costa Mesa prevails in that litigation addressing Federal Laws, it will not impact its view regarding State Housing Laws.
